Biennial Survey of Depository Libraries, 2005

Introduction

The 2005 Biennial Survey of Depository Libraries was sent to 1,263 depository libraries participating in the Federal Depository Library Program as of November, 2005. The survey was conducted online via World Wide Web during the month of December, 2005, allowing depository coordinators to <u>submit their responses online</u>. The survey questions as well as this report with compiled results are available on the GPO <u>Biennial Survey</u> web pages.

The purpose of the Biennial Survey is to report on conditions in the depository libraries. Required by law (44 USC §1909), the Biennial Survey gathers data from all the depository libraries every 2 years.

Submissions were received from 1,190 libraries resulting in a 94% response from FDLP participants. In some cases, responses were incomplete and could not be tabulated. Percentages may not add up to 100 because of rounding, incomplete or blank answers, or multiple answers.
