deborah rexon -> All Participants: Not giving titles of items - and assist patron in understanding how they can manage his/her account on line

Martha Ballinger -> All Participants: That makes sense.

deborah rexon -> All Participants: Or even ask them for a title of one of the books they have checked out ~38amp; verify due date

Kathy Hale -> All Participants: Our administration is asking us for statistics of who is using what to justify our existencce.

Martha Ballinger -> All Participants: Who is using what?

MARY BLOOMQUIST -> All Participants: Ask for the library card number, to verify they are the right person.

Thomas Fischlschweiger -> All Participants: They have to supply the inforamtion. They must supply the library account number, name and other info so we can look it up. But when someone calles and says they are on vacation and need their library card number so they can use e-books for example, we cannot give it to them. It's a delicate balance, and in Florida, there

are statutes that cover some of this. As privacy concerns increase, thiose statutes may change...

deborah rexon -> All Participants: In the longrun, if I can't verify who you are to my satisfaction, I can't give you that information

Sarah Erekson -> All Participants: I was reviewing the statement ~38quot;FOIA notwithstanding, librarians should be aware that nearly all government information about private individuals or entities is barred by law from being released to anyone because of privacy restrictions.~38quot; and I felt like it was not that simple anymore. It really seems like an overly broad and out-dated statement.

Thomas Fischlschweiger -> All Participants: At a DLC info session some years ago, some institutions were traciking docs usage online, but as part of setting up the system, the OPAC alos tracked the user's individual account. We would never be allowed to do that here.
