## WHAT IS GPO'S FEDERAL DIGITAL SYSTEM (FDSYS)?

FDsys automates the collection and dissemination of electronic information from all three branches of government.

- Information is:
  - Submitted directly into FDsys
  - Permanently available in electronic format
  - Authenticated and versioned
  - Publicly accessible for searching and downloading
- FDsys is a Content Management System
  - FDsys securely controls digital content throughout its lifecycle to ensure content integrity and authenticity
- FDsys is a Preservation Repository
  - FDsys follows archival system standards to ensure long-term preservation and access of digital content
- FDsys is an Advanced Search Engine
  - FDsys combines extensive metadata creation with modern search technology to ensure the highest quality search experience

#### **<u>HOW</u>** IS IT ALL DONE? (ROLES & RESPONSIBILITIES)

- The Community of Stakeholders is the reason for what we do:
  - Provides Functional Requirements and User Needs
  - Performs End User Testing of System Functionality
  - Provides Feedback
  - Uses the System
- GPO Business Units define requirements, set policies, and operate the system:
  - Define Functional Requirements
  - Set Priorities and Policies
  - Develop Standards
  - Perform End User Testing of System Functionality
  - Validate Requirements Have Been Met
  - Use and Operate the System
- The FDsys Information Technology Team designs, develops, and tests the system:
  - Captures, Analyzes, and Manages Requirements
  - Develops System Specifications from the Functional Requirements
  - Manages Scope, Schedule, and Cost
  - Creates System Design and Documentation
  - Develops Systems
  - Integrates Technologies and Systems
  - Performs System Testing
  - Operates and Maintains Systems
  - Reports on the Status of FDsys and Related Projects

### WHEN WILL FDSYS BECOME GPO'S ELECTRONIC SYSTEM OF RECORD?

The sunset of *GPO Access* is planned for the end of 2010. At this time, FDsys will assume the role as GPO's electronic system of record.

FDsys is a system that allows Federal content creators to easily create and submit content that can be preserved, authenticated, managed, and delivered upon request. As opposed to just being a content repository, it is a system that will continually be updated with new Federal content collections, and these collections will need to be refreshed and migrated over time.
