# DATABASES INCLUDED IN THE PACKAGE

HeinOnline's U.S. Academic Core package is designed to provide a base of content to meet your research needs. HeinOnline's databases are dedicated to treaties, constitutions, case law, world trials, classic treatises, international trade, foreign relations, and much more.

#### **American Enterprise Institute**

This database brings AEI's collection of scholarship to HeinOnline's fully searchable image-based format. Browse titles in HeinOnline by Policy Area or use the facets under Refine Your Search. Easily search the full text of all publications, including titles that have not yet been released by the AEI. We will update the database regularly with new content, and *will also be releasing nearly 400 archived documents*.

# Bremer-Kovacs Collection: Historic Documents Related to the Administrative Procedure Act of 1946 - *New*

This comprehensive database is designed to make the APA's history more accessible and understandable. The database is rounded out with various tools to help researchers navigate the database, understand the documents in their rich historical context, and quickly identify the material most relevant to the user's precise interests. A comprehensive timeline charting the Act's passage is also included.

#### **Canada Supreme Court Reports**

HeinOnline's Canada Supreme Court Reports contains the official, bilingual series published under authority of the Supreme Court Act. This database includes nearly 10,000 cases which include background information, statutes and regulations, authors cited, analysis and the decisions.

#### **Civil Rights and Social Justice**

#### **Code of Federal Regulations**

The Code of Federal Regulations (CFR) is the codification of the general and permanent rules and regulations (sometimes called administrative law) published in the Federal Register by the executive departments and agencies of the federal government of the United States.

#### **COVID-19: Pandemics Past and Present**

This database contains publications on the various ways COVID-19 has impacted every aspect of life, from testing issues in the medical field to unemployment and economic impact. #### **Criminal Justice & Criminology**

#### **Federal Register Library**

#### Gun Regulation and Legislation in America

#### Law Academy Project - New

#### Law Journal Library


#### World Constitutions Illustrated
