## Meetings:

The Steering Committee met with all NCSA steering committee members on April 17, 2024 and held 13 South NCSA Steering monthly meetings. Five meetings were open to the public. The Chair, Chair-Elect, and Secretary held one organizational meeting with our GPO representatives on May 20, 2024. Our last meeting for the Council year was held on May 15, 2024.

NCSA Steering Chairs met 9 times, including a meeting on May 9, 2025, with the four incoming chairs.

## **Accomplishments:**

- Limited Print Distribution Title Reallocation plan
- Two Surveys:

"Request for Feedback: South National Collection Service Area (South NCSA) Reallocation Proposal," September 2024 The South NCSA Steering Committee has <u>drafted a Reallocation Proposal</u> (with a <u>visual chart</u>) for <u>Print Distribution Titles (PDT)</u> titles, and we seek feedback from the South NCSA community. This proposal only addresses the process by which PDT titles will be reallocated if a depository decided to no longer receive the title, and it will not have an impact on legacy materials circulated before the switch to an All-Digital FDLP. Please respond by September 25, 2024. Thank you for your thoughtful feedback!

- For readability, you may want to include the question about the historical collection retention that's in the flow chart within the written progression as well.
- o Wouldn't mind a review at a meeting.
- o The only issue I might see is that over time the GPO Fall 2023 Interest Survey will become increasingly less relevant. Perhaps asking South NCSA libraries who generally would like to be first in line to take over PDTs to join a "waitlist" that gets contacted after the state Regional and other instate libraries turn a specific title down. That would let the two "blue" steps of other regionals and other selectives be combined into one step targeting libraries who have expressed an interest and willingness to take on one or more PDTs. Then if no interest it could be offered nationally. It would streamline the process, but a "waitlist" would have to be maintained and updated annually.

  - The plan seems reasonable, but, with so many institutions to be consulted, I am curious how long the offer process is supposed to take and who will be responsible for managing the different stages.
  - o I am neutral about the proposal and feel like more information is needed.

#### 2 Have some reservations

O Question #1 - is "interstate" the same as the "bordering state" or the closest regional library to the regional not wanting the material. How does the regional determine that, for example is Columbia, SC (184 miles) closer to Chapel Hill, than Charlottesville, VA (198 miles); if Georgia does not want something, will it always be offered first to UofSC because we are closer than other regionals? Please clarify.

Question #2 -It appears that Regionals are being asked to take on the "reallocation" burden with GPO only being "looped in" at stage 5. Since GPO created the "Limited Distribution Plan" it should take responsibility for reallocation in partnership with the affected regionals and affected National Collection Area, in this case NCA-South. This partnership should be clearly defined starting with step #2.

o I am grateful so few selective libraries in my state continued to select print because this plan seems to require a lot of labor from Regionals to track and offer these titles. I'm also finding it difficult to offer feedback when I don't know what other options were discussed and dismissed.

#### Comments not specifically about reallocation going forward:

- As a selective library that previously had a Print Selector agreement in place for the CFR, and had that agreement removed in order for another selective in our state to acquire the CFR title, I would very much be interested in knowing if would be willing to offer any CFR titles they replace annually, once the new editions are received. We are keeping the last version of each CFR title we have on our Reading Room shelves, but I would like to be able to have any that are deselected or replaced by current versions that Wake Forest may remove each year. Unless they are a preservation steward for the CFR of course!
- Would like information on the overall changes moving forward.
- I wonder about Marcive and the services they provided. Who will take this service over?


### "Request for Feedback: Creating a Service Area Collection Management Plan," January 2025

1. Our first task is to establish a "last copy" policy, but the order of later tasks is undecided. Which of the following issues should we prioritize? Please pick up to three.



## Other: "Assist Regionals with identifying others interested in Shared Regional Agreements


2. Would you be interested in serving on a temporary working group to assist steering? If so, please select the topic(s) of interest:


3. Is your institution interested in becoming a preservation steward for a limited print title. If so, which of these titles might you be interested in preserving?

As a result of the survey responses, we decided that we will retain a minimum of 4 copies of each limited print distribution title within the South NCSA and we created one working group: Leveraging Existing Networks (LEN) Working Group.

## **Levering Existing Networks (LEN) Working Group**

The Working Group was established in March 2025 to assess the impact of existing shared print collections within the South NCSA and provide recommendations to the South NCSA Steering Committee on optimizing access to FDLP materials in the region.

Charge: The Working Group for Leveraging Existing Networks will explore the impact of existing shared print collections within the South NCSA and make recommendations to the South NCSA Steering Committee for the best way to leverage these collections to maximize access to FDLP materials in the

region. This exploration should include but is not limited to looking at existing ASERL agreements and shared print collections between regionals.
