Established by the GPO Inspector General Act of 1988, the Office of the Inspector General conducts independent audits, inspections, and investigations of GPO programs and offers an independent and objective means of keeping the Director of the GPO and Congress fully informed about problems and deficiencies relating to the agency's administration and operations. Three divisions are responsible for fulfilling the OIG mission: Audits Division, Inspections/Program Analyses Division, and Investigations Division. In this session we will discuss the OIG mission, and how to report suspected wrongdoing to the OIG. We will also discuss examples of cases and fraud at GPO and how to be aware of fraud indicators.

1:00-2:00 Passing the Torch: Navigating a Government Documents Transition with Heart, Humor, and a Hint of Chaos

What happens when a longtime Government documents coordinator steps into a broader strategic role during a sweeping library reorganization, and another experienced librarian takes on the depository coordinator title for the first time? This session explores one library's coordinator transition amid shifting responsibilities, a major weeding project, and digital-first realities. Presenters will share how they approached the handoff from both sides: preparing documentation, managing institutional memory, and navigating all the feelings that come with saying goodbye—or hello—to a legacy collection. With a mix of practical tools and honest reflection, this session is for anyone preparing to pass the torch, receive it mid-stride, or just trying not to drop it entirely.

2:15-3:15 History Lab AI: A New Way to Explore a Vast Corpus of Declassified Documents

This session will provide a deep dive into History Lab AI, a free research tool built on a corpus of more than 5 million declassified government documents. The project's mission is to make historical records more accessible by enabling natural language and embedding-based search, offering a powerful alternative to traditional keyword methods. We will discuss the philosophy behind this approach, practical differences in search experiences, and principles of retrieval-augmented generation. Attendees will be encouraged to try the tool in real time, ask questions, and share feedback.

Government comics are one of the most interesting and fun aspects of the Government Publications collection at the University of North Texas Sycamore Library, but because they is scattered among many different agencies, take on a bewildering variety of formats, and are not always well-indexed in the library catalog, these fascinating publications all too often have languished unseen by and unknown to the general public and even to library staff. Join us as we share the thrilling story of how we have been discovering, preserving, and promoting Government comics at UNT's Sycamore Library. We will share the principles we have learned over the years — principles that can be applied at your own library, not just to Government comics, but to other hidden collections as well. Tracking Government Information is a crowdsourcing project to track removed and modified Government information and resources, and to point people to archived copies of content whenever possible. While libraries in the FDLP are familiar with our depository materials and are aware of the safeguards in place for digital depository materials, it can be harder to understand the impact of the currently changing Gov info landscape on information and data beyond the depository collection. In addition, many of us are receiving questions from our patrons on what is happening with Government information right now and how to find materials that they used to use that are no longer online. In this presentation, we will address current events, how the work of FDLP libraries intersects with broader public access concerns, and how depository librarians can play a role in identifying, documenting, and responding to risks to Federal information that fall outside the scope of traditional depository holdings. We will also discuss the value of collaboration between depository and non-depository efforts to support a more comprehensive national strategy for Government information access.
