To SuDoc or Not

organizing your documents collection to meet your patrons needs

Abstract

The Federal Depository Library Program allows individual libraries the freedom to arrange collections in the way that best suits local needs. Depository libraries of all kinds have made a variety of physical and classification decisions over time. As needs evolve, those decisions may need to be revisited. We will discuss how and when those decisions should be evaluated and what is involved in revising these collection decisions and processes associated with them.

Different models

- Entirely integrated collections
 - All materials are cataloged into a larger scheme (Library of Congress or Dewey)
- Partial integrated collections
 - Select materials are cataloged into LC or Dewey; some materials are kept in SuDoc & shelved separately
- Separate collections
 - Docs are in SuDoc; everything else is LC or Dewey

A million variations

- J 85 [Sudoc] scheme
- Serials only
- Primary law only
- Handpicked materials



Professional Center Library

- 4 Reference Librarians; 3 have served as documents coordinator at some point.
- As of 2015: 4 years; 7 years (me); 14 years; 18 years experience in this department
- Documents processing done by Collection Services staff member



Professional Center Library

- Fall 2014: director asked for a review of the collection development policy in advance of accreditation visit.
- December 2014: Presented to staff for comment
- January 15, 2015: requested final staff comment



Professional Center Library

• January 15-22, 2015: Protracted conversation with the head of Collection Services over a single point of controversy:

How do we catalog our Government Information?

...The Gist...

Public Services staff uniformly believed that documents were individually separated into SuDoc and LC schema depending on subject matter. Head of Collection Services: "we have not classified any new documents in LC for at least the last 15 years... a conscious decision was made... that we would keep serials... in LC but everything else would be... in SuDocs"

Diplomacy & Outreach

- Internal: conversations with director & staff to massage the wording of our policy
- External: outreach to colleagues to figure out how to move forward







Considerations

- Physical Arrangement
 - "Island of misfit toys" approach
 - Materials that require a lot of help for use
- Intellectual Arrangement (cataloging)

Considerations, cont.

- Workflow & processing new materials
- Retrospective processing existing materials
 - Keep old material as is until phased out?
 - Move permanently held material?
- Material type
 - Serials v. monographs?
 - Primary materials v. secondary materials

- Small selective ~3%
- Collection consists of:
 Primarily legal materials
 Social science
 Interdisciplinary subjects
- Most depository materials already integrated before this project

Process (Yale)

- Weed the SuDoc collection
- Update cataloging for titles retained
 - Reclass
 - Relabel
- Create discard list; follow offers process
- Suppress records for weeded materials
- Reuse physical space
