Fun Facts

- March 9, 2016 marked the 10th anniversary of the CGP.
- In FY17, we had nearly 35 million successful searches of the CGP.
- We have approximately 195 countries/entities that have accessed the CGP, based on domain extensions.
- There are over a million CGP bibliographic records, of which nearly 175,000 have PURLs.

Safeguarding Government Information Access for All

- Data Integrity
 - Works closely with Library Technical Services (LTS)
- System Availability
 - Security Focused
 - Uptime
 - Scheduled maintenance windows
 - Reduced unscheduled inaccessibility
 - Quicker response times when issues arise
 - Redundancy/Recovery
 - System regularly backed-up including environment, system applications, and data
 - Multiple contingencies including geographic separation and local offsite backups to allow for quick recovery in the event of a large-scale local outage

New Security Focused Activities

- Migrated the ILS including the CGP to Amazon Web Services FedRAMP (Federal Risk and Authorization Management Program) authorized cloud platform
- Implemented HTTPS on the CGP, MetaLib, FDLD, and PURLs
- Enhanced processes for system updates, upgrades, scans, tests, and continuous monitoring
- Certified Systems Security staff
 - (1 certified; others in training)
- Certified Privacy staff
 - (1 in training)
- LSCM management and staff attend a variety of security/privacy trainings and events each year to stay current.

What is FedRAMP?

- The Federal Risk and Authorization Management Program, or FedRAMP, is a government-wide program that provides a standardized approach to security assessment, authorization, and continuous monitoring for cloud products and services.
- This approach uses a "do once, use many times" framework that saves an estimated 30-40% of government costs, as well as both time and staff required to conduct redundant agency security assessments.
- FedRAMP is the result of close collaboration with cybersecurity and cloud experts from the General Services Administration (GSA), National Institute of Standards and Technology (NIST), Department of Homeland Security (DHS), Department of Defense (DOD), National Security Agency (NSA), Office of Management and Budget (OMB), the Federal Chief Information Officer (CIO) Council and its working groups, as well as private industry.
