- 2) Name one way that a U.S. citizen and Michigan resident may register to vote.
- A: You can register to vote for federal, state and local elections by mail, by visiting your county, city or township clerk's office or by visiting any Secretary of State branch office. In addition, specific agencies providing services through the Department of Human Services, the Department of Community Health and the Department of Career Development offer voter registration services to their clients. Military recruitment centers also provide voter registration services.

You can also register at the same time you renew your driver's license by mail. Eligible drivers will receive their voter registration applications in the mail with their driver's license renewal information.

A: Debt collection practices are governed by the "Fair Debt Collections Practices Act," which provides you with a variety of rights, including protection from harassing phone calls.




