- First Biennial Survey conducted in 1947
- 44 USC §1909
- Different names, formats, and questions over the years

# 2017 Biennial Survey

- Open from October 23, 2017 to November 30, 2017
- 1,095 responses received from 1,143 active depositories (96% return rate)
  - GPO follows up with non-responders
- New in 2017 survey
  - Questions about collection size and cataloging
  - Region reports
  - (Still working on: Biennial Survey map)



# New Questions in 2017 Biennial Survey

- Have you read / any questions about LRPR?
- Questions for depositories with tangible formats
  - Estimated collection sizes: paper, microfiche, tangible electronic (CD/DVDs, etc.)
  - Weeding plans
  - How much of the depository collection is cataloged?

# Methodology

- Of the survey's 23 questions:
  - Quantitative 11
  - Quantitative with a qualitative (open-ended) component 8
  - Qualitative 4
- Data matching and clean-up
  - Excel data into SAS, match-merged with library demographic identifiers
  - Grouping data from "select all that apply" questions
- Question analysis in Excel
  - Pivot tables
  - Coding of open-ended responses


- Plan to remain in the FDLP? 91% "yes"

• Many libraries who responded "no" in the past are still in the FDLP



• Digital has not won yet...22 libraries identify as all digital







Other library types (2 of 3)






What are the biggest issues facing your library?



#### All other library types – further responses








# How do you provide access to online resources?
