Two constant themes pervade the course of my 30+ years working in depository libraries: new technologies and reorganization. It is more than change management as with each of these themes is a need to learn more, learn quicker, and assume more responsibility. I have observed most depository librarians manage to balance change well yet all this new learning and responsibility leads to "TechnoStress," a 1980s term where our brains are saturated with technologies and do not shut off so we start to feel withdrawal from it. Is this a rationale for the loss in interest in Government publications both in production and in preservation? Are librarians simply worn out with the increasing demands in learning new technologies? This presentation examines the roots of TechnoStress, its impacts on the field of depository librarianship, and its potential impact on the preservation of Government information. Last, we conclude examining the importance of self-care as part of a preservation program.

This presentation will offer an overview of the various Soviet intelligence services, their evolution, and their post-Soviet successors, as well as a brief history of their operations in America, down to the present. In addition, tips and guidance on how and where to research this topic, especially how to find Federal Government information, will be provided.

Text mining is a research method that has experienced increased interest in recent years, and Federal Government information, primary source material in the public domain, is a natural set of data to mine. Researchers from fields such as political science, history, and economics seek to mine Government documents, but connecting potential text miners to relevant data is one of the major challenges in supporting this area of research. This session will provide an overview of text mining as it relates to Government publications, including major methods and tools, data sources, and needs, as well as the ways in which librarians can engage with data-driven research. It will provide hands-on experience with selected data and tools, primarily from HathiTrust and the HathiTrust Research Center.

What Is in Those Compact Shelves? Auditing and Quantifying a Government Documents Collection

In order to properly assess a regional collection's needs and to prepare for the future, library staff needed to identify baseline data. Over the past six months, Government Information Department staff developed and implemented a Stacks/Collection Audit using open source tools. This presentation will cover the purpose, methodology, resources, implementation, limitations, and outcomes of a stacks/collection audit conducted in a regional FDLP collection at an academic library. Results of the audit included information about the extent of SuDoc stems, locations of needed collection maintenance, and rough estimates of numbers of materials by format and SuDoc stem. The planning and implementation of this project may be useful to other FDLP coordinators who wish to know more about specific parts of their collection, are anticipating a move or shifting project, are preparing for a preservation audit, or are planning a retrospective cataloging project. Additionally, the audit provided data that better describes the Government documents collection to stakeholders, inside and outside the library, through visualizations and reports. Links to the open source tools will be available to attendees who wish to participate in a hands-on manner during the session.

Examples will highlight how blogs, alert services, and others can help identify, contextualize, and share the most relevant information from web-based Government sources to facilitate access to justice.

In 1945, shortly after WWII our predecessor agency, the Air documents Division, started a collection that consisted primarily of captured Japanese and German scientific documents. For the next 70 plus years, the Defense Technical Information Center has been collecting, processing, preserving, and protecting scientific and technical (S&T) information. Our mission is to acquire, store, retrieve, and disseminate the Department of Defense's S&T information and deliver the knowledge needed to develop the next generation of technologies to support our warfighters. DTIC has a history! Today, DTIC is much more than a repository for S&T reports. DTIC provides resources and tools in three environments – Public, NIPRnet, and SIPRnet. The R&E Gateway is an ideal tool for saving time and resources for scientists, researchers, engineers, librarians, program managers, students, and anyone looking for science, technical, research, and engineering information. DTIC offers you two types of Collaboration tools – DoDTechSpace and DoDTechipedia.

As a DTIC user you will have access to over four million items of public and controlled access scientific and technical information. As a contributor of S&T information to DTIC, you can be sure that your research will be protected by the distribution statements assigned to it and will be accessible to future generations. Your research efforts will not be lost in a filing cabinet or trashed.

Heather Christenson will discuss HathiTrust's digital Federal documents collection built-in collaboration by the HathiTrust member libraries and housed in the HathiTrust Digital Library for preservation and access. We hope FedDocArc can serve as a model for depository libraries that want to work together to build a collection for the benefit of their institutions and the people of their state.
