BLACK HISTORY

History Vault: Southern Life and African American History, 1775–1915, Plantation Records, Part 3

COMING IN Q4 2021! This module represents the third installment of ProQuest's digitization of its important collection of Records of Southern Plantations. Part 3 consists of collections selected from the holdings of the Southern Historical Collection, University of North Carolina at Chapel Hill. These collections represent rice, cotton, and sugar plantations in North Carolina, South Carolina, Georgia, Florida, Louisiana, Mississippi and Arkansas. The Cameron Family Papers chart the rise of a plantation family beginning in 1770, when the family ran a country store along an Indian trail in central North Carolina. The Cameron Family Papers document plantation management by women during the men's absences. The Pettigrew Family Papers recount the history of an influential coastal North Carolina family of planters, ministers, intellectuals, military officers, and politicians. The candor of the Pettigrew letters on slavery has been of value to historians for many years. Part 3 also includes several collections of cotton factors' records, notably the records of Maunsell White from Louisiana, and the Gordon family from Savannah, Georgia. As the financial fulcrum of the cotton trade, the factor served as the planters' banker, supplier and sales agent. Records from Mississippi plantations include a number of diaries documenting daily life. Other topics covered in Part 3 are the lives of the enslaved people, Southern politics, and the settlement of the Southern frontier in Arkansas and Mississippi.

The Rolling Stone Archive

NEW! The backfile of *Rolling Stone* magazine, from its launch in 1967 to the present. One of the most influential consumer magazines of the 20th–21st centuries, it initially sought to reflect the cultural, social, and political outlook of a generation of students and young adults. It soon became a leading vehicle for rock and popular music journalism, shaping and chronicling new trends and movements. Also notable for its commitment to reporting on controversial topics that were largely absent from mainstream media, *Rolling Stone* was closely identified with a multifaceted 1960s–70s counter-culture. Major journalists and authors to have contributed include Hunter S. Thompson, Patti Smith, and Tom Wolfe.

It has subsequently expanded its coverage to encompass further entertainment topics such as film and television, and is a leading resource for contemporary reporting and reviews pertaining to wider popular culture. The archive will support research in 20th/21st-century history and politics, music, cultural studies, media studies, sociology, and more.

Entertainment Industry Magazine Archive IV - Music - Folk, Rock & Hip Hop

COMING IN SEPTEMBER 2021! The backfiles of over 40 magazines devoted to major genres of 20th/21st-century popular music – rock, folk, and hip hop. Coverage spans 75 years, from the mid-1940s to 2020. As well as charting the history of these musical movements, the publications, from outside of the mainstream, express cultural, aesthetic, and political responses to their historical period; they reveal the fashion, style, and rhetoric of these communities.

- Rock magazines, many originating in the 1960s and 70s capture how rock music represented a language of dissent and challenge to the status quo at this time, documenting contemporary social issues, the evolution and growth of youth culture, and associated fashion/style trends.
- Folk music titles span traditional and contemporary folk, bluegrass, world music, and related genres from the mid-20th century to the present. They notably shed light on the Folk Revival of the 1960s and the preceding decades, with this movement being a vehicle for activism, awareness and protest, contributing to social change.
- Hip hop and rap magazines capture the rise of this genre from the 1980s forward, covering artists, musicians, music venues, block parties and performance art (such as breakdancing, scratching, and turntablism). These titles convey the social implications of an oppositional culture challenging racism and stereotypes. They also they document the material culture that grew out of this movement.



The Artforum Archive

COMING IN OCTOBER 2021! The backfile of *Artforum* (later *Artforum International*), the leading magazine for coverage of international contemporary art, from its launch in 1962 to 2020.

The archive spans six decades of reporting on art in all media, from painting, sculpture, and installation, through to body art, video / audio art, and performance art. Artforum contains features, reviews, and interviews relating to artists, exhibitions, publications, and other aspects of the art world. It has notably published original art, photography, and essays by major practitioners, such as Robert Smithson, Jasper Johns, Nan Goldin, Laurie Anderson, Bruce Conner, and Robert Mapplethorpe. It has equally been renowned throughout its history for featuring leading critics, many of whom – for example Michael Fried and Barbara Rose – wrote for the magazine early in their careers.

Artforum also covers adjacent cultural forms including architecture, film, fashion, photography, and music; the archive will support research across a range of topics in popular culture, as well as in 20th-century history, politics, the history of economics / marketing, and more.

EARLY MODERN HISTORY

Early European Books 19 – Travel Writing and Literature (French Arsenal Collection)

COMING IN AUGUST 2021! This collection will cover materials from the Bibliothèque nationale de France with a thematic focus on travel literature of approximately 500,000 pages and more than 2000 works. Also included are government travel reports, letters, religious journals, ethnographic monographs and writings inspired by travel within and beyond European borders. The collection includes the travels of Jean De Mandeville (1300–1372), the earliest surviving texts in French as he travels to places such as Jerusalem. These works heavily influenced later travelers, including Christopher Columbus. It also includes Jean Donneau de Visé (1638–1710), a French journalist, royal historian, playwright and publicist covering descriptions of the travels of the ambassadors of Siam to France. Also, a wealth of maps and images by French geographer Pierre Duval (1619–1683) are captured and fully discoverable.

Early English Books Online (Content addition)

COMING IN Q4 2021! EEBO new content release will cover over 260 new titles from STC 95 and Wing 145.

The EEBO release covers contributions from the Catholic church, Church of England and Scotland as well works from the prominent Huguenot leader, Louis de Bourbon, Prince of Condé and the Puritan Ezekiel Culverwell's A treatise of faith. There is a rich collection of musical notations – over 60 images – contained within Common prayer books and psalms where "with apt notes to sing them withall; set forth and allowed to be song in all churches.." collected by T. Sternhold and I. Hopkins (1580). Composer John Wilson (1595–1674) offers a curated selection of "musicall ayres, and dialogues, for one and two voyces, to sing to the theorbo, lute, or basse viol..." The collection is also replete with other document features such as coats of arms, portraits and maps.

Cultural and political life in early modern Britain is captured through the works of Edward Bennett (1620) who provides insights into "the inconueniences, that the importation of tobacco out of Spaine, hath brought into this land." Whilst William Ashhurst (1617–1680) debates the Foundations of Freedom published by the government as not constituting freedom but tyranny and slavery to the people. Defoe's "Essay on Projects" (1697) was his first volume published and it contains a series of ideas and thoughts – such as advocating the education of women – that ultimately looked to enhance the moral well-being of society.

LATINO HISTORY

History Vault: Latino Civil Rights during the Carter Administration

NEW! Latino Civil Rights During the Carter Administration gives rich insight into the efforts of the Executive Branch of U.S. government to reach out to the burgeoning Latino population during the last 2 years of the Carter Administration. In the summer of 1979, the Carter Administration created the White House Office of Hispanic Affairs in order to address issues of critical importance to the Latino community. The coming decade of the 1980s was being hailed as "the Decade of the Hispanic," and many were looking to the president and Congress to show more respect for Latinos and their manifold contributions to the United States. Major topics covered in this collection include inflation, bilingual education, police brutality, political unrest in Latin America, Haitian refugees, and immigration (legal and otherwise), Puerto Rican self-determination, and the U.S. Navy's use of Viegues Island. Latino Civil Rights during the Carter Administration also documents some of the most important Latino organizations of the time, including LULAC, TELACU, La Raza, the Puerto Rican Legal Defense and Education Fund, the Mexican American Legal Defense and Education Fund, and the American G.I. Forum.

DNSA: Donald Rumsfeld's Snowflakes, Part II: The Pentagon and U.S. Foreign Policy, 2004–2006

NEW! Focusing on the second half of the Bush administration, these documents complete the Archive's collection of Donald Rumsfeld's "snowflakes." Obtained through a FOIA lawsuit, these signature memos and often lengthy staff responses offer glimpses into Rumsfeld's day-to-day concerns ranging from DOD's reconstruction efforts in Afghanistan and Iraq, the Iraqi insurgency, and investigations of detainee abuse at Abu Ghraib and Guantanamo Bay to disaster relief following the Indian Ocean tsunami and Hurricane Katrina, and ongoing communications with the White House, Congress, and the news media.

DNSA: CIA Covert Operations, Part IV: Eisenhower Years, 1953–1961

COMING IN DECEMBER! This collection will focus on a highly active, if checkered, period in the history of the Central Intelligence Agency, during which President Dwight D. Eisenhower authorized numerous clandestine programs around the world. These include Iran 1953 (the infamous coup whose reverberations are still felt today), Tibet 1956–57, and the Congo beginning in 1960. A highlight will be Eisenhower's original decision and plans to mount operations against Castro's Cuba that led to the Bay of Pigs. The set will thus dovetail neatly with previous DNSA publications covering not only events in Cuba during this timeframe but also in Berlin, Guatemala, and Vietnam.

U.S. HISTORY

History Vault: American Federation of Labor. Samuel Gompers Era Records, 1877–1937

COMING IN SEPTEMBER! As leader of the American Federation of Labor. Samuel Gompers (1850–1924) championed a set of tactics and an ideology, rooted in craft-union traditions, which profoundly shaped the course of American labor history. Over 350,000 pages of union documentation throw light on the momentous struggles within the American labor movement during and just after the Samuel Gompers era. Most of the records in the collection date from the formation of the AFL in 1886 until Gompers' death in December 1924, but there are a few materials from before 1886 and after 1924. One of the strengths of this collection is its documentation of Gompers' own activities. Gompers' general correspondence, speeches and writings, conferences, and congressional testimony make up a major portion of the collection. In addition, the National and International Union Correspondence consists largely of letters to and from Gompers. The materials in this collection reveal the personalities, issues and ideas that forged the modern American labor movement.

Women's Magazine Archive 3

NEW! The third collection of Women's Magazine Archive expands the program by making available the backfiles of leading publications from the UK and Canada, adding valuable international contexts. It includes the UK editions of premier titles – *Good Housekeeping* and *Cosmopolitan* – among other major brands originating in the UK (*Prima, She, Company*) and Canada (*Flare*).

Women and Social Movements in the United States, 1600–2000

Women and Social Movements in the United States, 1600–2000 is an e-journal that seeks to advance scholarly debates and make women's history accessible to teachers and students at universities, colleges, and high schools.

NEW! The highlights from the Spring Issue include:

- Document Project: Bonnie Laughlin-Schultz's Having It All: Lucy Stone, Motherhood, and the Woman's Rights Movement, 1851– 1893 explores how the well-known woman's rights advocate Lucy Stone viewed and experienced marriage and motherhood. Personal letters reveal Stone's struggle to balance the demands of motherhood and her desire to participate in public life—a struggle that will resonate with many readers today.
- Document Project: Haleigh Marcello's The National Organization for Women, the Equal Rights Amendment, and California NOW Chapters' Lesbian Feminist Activism, Haleigh Marcello demonstrates how the National Organization for Women (NOW) dealt with the question of lesbianism in the 1970s while pursuing its central goal: ratification of the Equal Rights Amendment (ERA).
- Also features a roundtable on the historic significance of Kamala Harris' election as Vice President of the United States.


- Document Project: The National Organization for Women, the Equal Rights Amendment and California NOW Chapters, Lesbian Feminist Activism
- Document Project: Alina R. Méndez, Gendered Invisibility: Ethnic Mexican Women and the Bracero Program, focuses on the Bracero Program (1942–1964), under which thousands of Mexicans came to the United States as contract laborers. Although the vast majority of braceros were men, the program dramatically affected women—the wives left behind, those who accompanied their husbands, and the Mexican-American women who formed relationships with migrant workers.
- Document Project: Rima Lunin Schultz, The Wife of Jane Addams, drawing primarily on letters between Mary Roset Smith and Addams, as well as correspondence with friends, the project illuminates one of the most consequential and richly documented same-sex relationships in American history.

Women and Social Movements: Development in the Global South: 1919–2019, Jill Jensen

COMING IN NOVEMBER! Women and Development: The Social Movements, 1919-2019 examines efforts to foster gender equity through expanded economic and social participation of women on a global scale. Covering a century, the database highlights and evaluates activism through individual efforts, organizational initiatives, and socio-cultural projects led by women in the Global North and the Global South. It shows how women have negotiated power and status regarding private or public programs centered on their rights and social inclusion. Stressing the historical problem of the "feminization of poverty," coupled with women's invisibility within most foreign aid regimes and approaches to technical assistance, the project documents how women and their allies worked to balance economic growth and social improvement while navigating equity and the fairer allocation of resources. Accompanying essays by leading scholars in the field outline and critique significant shifts in approaches to development, including that of a gendered "postdevelopment" perspective.


