If you aren't logged in and are looking for a library in the drop-down, you do need to search by library name, not institution name. Many don't know their FDL number by heart, so...if your library has any more specific name than "Main Library" you can change it!

**Lara Flint** -> All Participants: Mary - the easiest way to "update" an inquiry in askGPO is to use the email functionality. I wrote down your suggestion though, thanks!

**Lucy Duhon** -> All Participants: Ive been having trouble resetting my p/w in askGPO - it sends me in circles. Anyone else experiencing this?

**James Jacobs** -> All Participants: If CGP were a true union catalog, then eXchange could rely on FDLP library holdings in alerting to offers that fill gaps
