Perveen Rustomfram -> All Participants: What will an all digital FDLP look like? Will catalog records have PURLs or will this mean digital deposit?

Arlene Weible -> All Participants: As an observer, I'll comment that the question that needs to be explored needs to be clarified. There are many e-only selectives right now, so what is the question?

Cindy Etkin -> All Participants: Here's the text of the recommendation: GPO, working with the DLC, begin to explore and discuss with the FDLP community the possibility of an all-digital FDLP. To facilitate this discussion, Council further recommends GPO develop a white paper defining what an all-digital FDLP or, in the alternative, a primarily digital FDLP might look like. The resulting white paper is to be shared with Council and the community for comments with GPO reporting on the resulting comments at the proper time.

Stephen Parks -> All Participants: It's to explore what a digital-only Program would be like ...

not what a digital-only library would be like ... was my understanding

Arlene Weible -> All Participants: Thanks for the clarification, Stephen. An individual FDLP library knows what it needs to do to be e-only, but the program as a whole being all digital is a whole other discussion

Arlene Weible -> All Participants: Sounds like what needs to be done is develop some models of what an all-digital FDLP program could look like

Donald Sensabaugh -> All Participants: I agree Arlene

Perveen Rustomfram -> All Participants: Agree with Arlene

Arlene Weible -> All Participants: Developing possible models would help make the conversation about the issue more clear

Cindy Etkin -> All Participants: If this moves forward as a recommendation to GPO -- all of these questions are good ones that would need to be considered as part of exploration. As the recommendation says, this should be done with the FDLP community. No difinitive answers today. There would be plenty of opportunities for input by the community.

Renee Bosman -> All Participants: I think that "moving towards" terminology is key; it's helpful to think of exploring it as a continuum.

Sheila Dorsey -> All Participants: A Preservation Steward library might be allowed to keep only those titles in the preservation model. It could accellerate the discard process.

Arlene Weible -> All Participants: I think the community would like to understand the method of exploration DLC plans to use

Shari Laster -> All Participants: +1 Arlene
