## **Council Action Items** Recommendations from DODLWG

- The Depository Library Council recommends that GPO:
  - Encourage depository libraries to examine lessons learned during remote work/COVID-19.
  - Encourage flexibility for depository library staff.
  - Working with the DLC, begin to explore and discuss with the FDLP community the possibility of an all-digital FDLP.





## **Council Action Items (cont)**

- Commendation to GPO staff for all their work moving the conference to completely virtual and supporting depository libraries as they move through the pandemic
- Recommendation for more open forums and continued support and flexibility for depository libraries as we continue to deal with the pandemic
