If I find it there and confirm it is a govpub, then I send it to GPO. Sometimes I send it to confirm it was indeed a depository document or something out of scope at the time.

Jenny Groome -> All Participants: I was told to remember to bring this up again - when a change comes, cataloguers have to update records and reference/instruction librarians have to update research guides. So it it double the work. It would be great to be able to use a find and replace tool.
