The FDLP, the Pandemic, and LTS

- FDLP materials processed by LTS staff.
- Critical parts of FDLP publications scanned and sent as attachments.
- Bibliographic, and other metadata entered onto a shared tracking sheet.
- Tangible publications mailed directly from Laurel Distribution Facility.
- LTS staff classify, catalog, and return Aleph system numbers for each item.
- PCC review/authentication review performed onsite.

Outreach to Tribal Libraries and Historically Black Colleges and Universities (HBCUs)

- LTS is keenly aware and actively monitoring the library community discussions and developments in building diversity, equity, and inclusion (DEI).

Cataloging Policy and Documentation Committee (CPDC)

- Revising sections of the General Policies chapter of the GPO Cataloging Guidelines.
- Main access point-Uniform Title subfield (\$h) for "Medium" in MARC 130 field, and Uniform Title in MARC 240 field removed by OCLC.
- LTS worked with OCLC, the Program for Cooperative Cataloging (PCC) and the Monographic Bibliographic Record Cooperative Program (BIBCO) representatives.
- OCLC is now retaining the subfield (\$h) Medium for use in GPO Braille and other expression records.
- Superintendent of Documents Classification section for the BIBCO Manual updated.

Revised Training Methods of LTS Staff

- Training continues for new staff during the pandemic.
- Four new Technical Services Librarians joined LTS since last October 2020; all 100% telework-eligible positions.
- All training sessions are presented through a video conferencing platform, with training sessions being recorded.
- Use of the recordings enable multiple viewings by new LTS staff.
- Seeing enhanced learning, quicker absorption of material, and confidence with new skills and knowledge acquired.

- Began obsolete category classes clean-up subproject.
- Addresses, Bibliographies, Lists of Publications, and Directories.
- Inactivating SuDocs stems and item numbers.
- "No Hits" SuDocs stems
 - 64 Category classes removed from the List of Classes.
- WEBTech notes published for all removals.
- Approximately 219 more class stems from these same category classes planned for removal.

Historic Shelflist Project (HSL) Update

- New contract awarded for Fiscal Year 2022.
- Contractors will continue to work on cataloging cards from the HSL.
 - Estimated 66,000-88,000 HSL cards remain.
 - Approximately 66,000 titles estimated.
- Cataloging will occur in OCLC's bibliographic utility; with export into the Catalog of U.S. Government Publications (CGP).
- Find all HSL records under "Historic Shelflist" or search for specific titles using the Historic Shelflist Catalog Search Box.

- Develop and implement automated methods and tools to facilitate and expedite our workflows.
- Capitalize on structured metadata to advance our processes.
- Enable our staff members to apply their expertise, knowledge, and talents to the most challenging and demanding aspects of our work.
- Gain efficiencies and time savings with respect to the repeated actions of our procedures and practices.
- Incorporate the automated methods and tools into our processes and build our operational infrastructure.



LTS Cataloging/Metadata Initiatives

- Unreported Publications.
- Document Discovery Submissions.
- Online Version Records for Digitization Processes.
- Acquisitions and Basic Records.



Unreported Publications Processing & Cataloging

- Over the past five years, received over 3,000 askGPO inquiries of unreported publications.
- Export the metadata submitted in the form on askGPO.
- Batch process the structured metadata into MARC records.
- Import the MARC records into OCLC for cataloging.
- Reduce data entry time and effort and create opportunities for global enhancements.
- Since April 2021, tagged records cataloged for the unreported publications.
- Posted data on the Reporting Publications to GPO page on FDLP.gov.

Document Discovery Process

- Federal agencies notify GPO of publications that they have newly issued according to Title 44.
- Submit spreadsheets of publications via askGPO.
- Use automated processes to convert the structured metadata into preliminary MARC records.
- Import the MARC records into OCLC.
- Complete the records.
- Add the records to the CGP.

Cataloging Online Versions for Digitization

- Need to catalog MARC records for GPO's digitization processes.
- Test the use of the MARC 583 Action Note field to indicate our intention to digitize publications.
- Produce the records in OCLC and add them to the CGP.
- Streamline the cataloging process and expedite the digitization process.
- Provide faster access to the digitized publications and distribution of the online version records.

Acquisitions and Basic Records

- Review our policies on brief bibliographic records and encoding levels.
- Launched the brief bibliographic records process in 2014.
- Purpose to expand our options for managing the high volume of publications that we catalog.
- Acquisitions records (MARC encoding level 5)

 Create for Cataloging and Indexing orders.
 Essentially the same as brief bibs.
- Basic records (MARC encoding level 3)
 - Catalog records with adequate metadata to describe and provide access to the publications.
- Update the GPO Cataloging Guidelines, Overview chapter, Cataloging/Metadata Encoding Levels Policies section to document these changes.

Continuing resource cataloging training program

- Developed comprehensive training sessions for:
 - Cataloging serial and integrating resource bibliographic records.
 - SuDoc classification and item number assignment.
 - Cataloging holding and item level data.
- Independence plan, review, and tracking.





ISSN workflow

- Revised criteria for making ISSN determinations.
- Established GPO catalogers responsible for ISSN assignment.
- Conducted training sessions with ISSN Center for using ISSN Uplink.



FRASER project progress

- Cataloging for 2,123 of the 2,224 backlog entries have been evaluated/completed.
- Quarterly new title lists maintained and current.

 - Generated by a National Park Service brochure.
- Charles Young Buffalo Soldiers National Monument (Wilberforce, Ohio)
 - Generated by a National Park Service brochure.



Library of Congress Subject Headings (LCSH) Proposals (aka SACO proposals) – *continued*

- Inspectors general
 - Generated by Congressional Research Service reports such as *Legislative proposals* related to the removal of inspectors general in the 116th Congress.



Most subject proposals are more mundane

- 5G mobile communication systems--Security measures
 - Generated by *National strategy to secure 5G*, and other publications.
- Freshwater lenses
 - Generated by Hydrogeology in the area of a freshwater lens in the Floridan aquifer system.
- Rhodhiss Lake (N.C.)
 - Generated by a U.S. Geological Survey report.

Global update in the CGP

- 747 records for various environmental impact statements.
- Contained mis-assigned subject heading, "Environmental impact statements".
- These publications are not about "Environmental impact statements" they *are* environmental impact statements.
- Changed this LCSH to an LCGFT (Genre-form term) in 747 records.
- Ensured that no geographic subdivisions or headings were removed.



Original vs. Official RDA

- The new RDA became the "official" RDA when the Toolkit was elevated out of beta status on December 15, 2020.
- Official RDA is now in use worldwide.
- The original RDA, which LTS is still using, is sometimes referred to as "classic".



Official RDA at GPO

- New RDA is not yet adopted by the Program for Cooperative Cataloging (PCC).
- PCC is developing additional documentation and training.
- LSCM will make the switch along with PCC.
- The switch is expected no earlier than July 2022.



RDA/3R Project Team at GPO

- Identify and document aspects of the new system that differ from current practice.
- Identify and collocate existing training resources which can be utilized by LTS.
- Design training sessions and materials for LTS staff which focus on applying the new RDA to Government information products.
- Draft guidelines for cataloging workflows to conform to the new model.

LC-PCC Policy Statements

This entity is an *entity subtype*.

For a more general description, use the *entity supertype*:

• RDA Entity 🕣

Describe an instance of an entity by recording a *metadata description set* that consists of one or more *metadata statements* using one or more elements assigned to the entity.

An element may be used more than once.

PCC practice: Use the "provider-neutral" approach described in the Metadata Guidance documents when cataloging Print on Demand (POD) reproductions and photocopies of textual materials, scores, and cartographic materials. This approach will result in a single PCC record that represents multiple POD reproductions and photocopies of the same original resource. Do not apply this technique to regular print publications, republications, reprints, facsimile reproductions, etc., or to microform reproductions. Use this technique



Metadata Guidance Documents

- In development by LC and PCC.
- Clarify RDA rules and LC-PCC Policy Statements
 - Examples
 - Explanatory text
 - MARC coding
- Similar to DCM Z1, BIBCO Standard Record, CONSER Standard Record.



Metadata Guidance Documents

- Estimated timeline from LC & PCC:
 - Writing should be complete in October 2022.
 - MGDs will be available on Library of Congress website in November or December.
 - Links to MGDs will hopefully be added in the LC-PCC PS.

The U.S. Government Publishing Office (GPO), Library Services and Content Management (LSCM) is preparing to adopt a new iteration of the cataloging standard Resource Description and Access (RDA).


RDA is used in metadata services for the FDLP and Cataloging and Indexing Program (C&I). Staff in LSCM's Library Technical Services (LTS) use RDA and the RDA Toolkit on a daily basis to catalog U.S. Government information products and to create and maintain name authority records.

The new RDA features both a redesigned RDA Toolkit and implementation of the Library Reference Model (LRM). The RDA Toolkit Restructure and Redesign Project, also known as the 3R Project, released a beta version of the redesigned RDA Toolkit in 2018. The new RDA later became official when the Toolkit was elevated out of beta status on December 15, 2020.
