Jon Quandt -> All Participants: Long-term, we're looking to provide relationships across more of our content, including across branches where it makes sense.

Jenny Groome -> All Participants: exactly Bernadine - and those loaned could be damaged, lost, etc. need more than 4 tangible copies

Bernadine Abbott Hoduski -> All Participants: many of docs at NARA were dismembered by READEX for fiching and no longer in preservation shape. need inventory of GPO docs at NARA and damaged docs replaced. otherwise do not claim we have viable backup for many years.

James Jacobs -> All Participants: Bernadine, the Internet archive is actively gearing up its microfiche digitization workflow

James Jacobs -> All Participants: Will need to figure out ways to connect historic print collections with born-digital collections. I'm thinking especially of the serials conundrum

Simon Healey -> All Participants: a clarification on subsuring fiche ... we only have to indivdually the paper, EL was auto done by GPO ... or do we have to also select for EL versions of fiche??

Bernadine Abbott Hoduski -> All Participants: good to hear

Jenny Groome -> All Participants: Great to hear James! Although Fed gov't should be responsible for this.

Rich Gause -> All Participants: Is there an active emphasis to create digital versions for ALL of the microfiche item numbers? Switching to paper isn't a real option for us, so dropping the microfiche created a loss of any access at all for some committees.

Jenny Groome -> All Participants: What happens when Preservation Stewards get new director who wants to give up the responsibility?

Shawn King -> All Participants: When does "Day Forward" start exactly?

Jenny Groome -> All Participants: Bernadine - a regional could be preservation steward for only a specific area of collecton.

Jenny Groome -> All Participants: Good question Shawn

Abigail McDermott -> All Participants: Yes, Bernadine, it would take me a few minutes to get you a precise count of how many regional depository libraries are also Preservation Stewards for some subset for their collections, but Preservation Steward partnerships are a print retention agreement beyond what is required by Title 44 for regional depositories.

Abigail McDermott -> All Participants: Both selective depositories and regional depositories can serve as Preservation Stewards!

Abigail McDermott -> All Participants: Shawn, "day forward" means from the signing of the Preservation Steward agreement to preserve titles going foward, into the future.

Abigail McDermott -> All Participants: A Preservation Steward agreement can be either for material currently held by a depository or for material they are willing to agree to continue to receive in print going foward - or both!

Jenny Groome -> All Participants: But the role of Regionals were to be "perservation stewards" - add to their collections missing items withdrawn by selectives. When I worked at selectives, long term collection development decisions were made based on this understanding and the distance to Regional Jen Kirk -> All Participants: At USU, we were happy to host GPO a couple of weeks ago. I am thrilled to see our resources formally joing the National Collection and I look forward to seeing outcomes from the pilot project in the coming months.

Abigail McDermott -> All Participants: All Preservation Steward agreements will be accompanied by an inventory to ensure we are aware of what is covered by this crucial partnership agreement. Those inventories may look different for those agreeing to hold previously distributed material vs. print material "day forward"

Bernadine Abbott Hoduski -> All Participants: Steve and Carlos at Utah did an incredible job building the utah collection.

Rich Gause -> All Participants: I'm in favor of and support the preservation steward program. One of the main problems is that when the eventual benefits are touted, many library directors only hear the message "this allows you to start weeding your entire collection because somebody else has agreed to take that responsibility" - but they fail to realize that we're not there yet, so if lots of libraries toss their existing collections then there won't be anything left for future preservation stewards to acquire from discards.

Paul Nease -> All Participants: I would love to see a webinar given by a library that became a preservation steward. To see what the process what like, and what they learned during the process. Seeing that up front from a library's perspective would be really helpful
