Preservation

Strategic initiatives, programs, and processes designed to maintain useful access to information assets, serving the information needs of both present and future generations.



The National Collection of U.S. Government Public Information

The National Collection of U.S. Government Public Information is a geographically dispersed collection of the corpus of Federal Government public information, accessible to the public at no cost. The development, maintenance, and preservation of the National Collection is critical to providing free, ready, and permanent public access to Federal Government information, now and for future generations.



The Digital National Collection

The digital National Collection includes GovInfo (GPO's ISO 16363 certified Trustworthy Digital Repository), content harvested by GPO, and content hosted on Federal agency websites. GPO partners also help build the digital collection by contributing digitally reformatted content for ingest into GovInfo or hosting digital content in their own repositories. The digital National Collection is essential for providing free, ready, and permanent access to Federal Government information, now and for future generations.

GPO will do this by digitizing documents and making them accessible on GovInfo and the Catalog of U.S. Government Publications (CGP)

- The National Collection is a valuable information asset
- The physical National Collection held in Federal Depository Libraries has unique, regional content
- Most of the legacy collection is not already online

The National Collection Focus

1850 to 1950

Machine made paper era

Before 1850 government publishing not as prolific

Most earlier serials already preserved

After 1950 focused on selected areas of interest

Current and Future Planning

National Collection Strategic Plan Released

The Superintendent of Documents released the, "National Collection of U.S. Government Public Information: Strategic Plan for FY 2023 — FY 2027," today, September 6, 2022. The focus of this strategic plan is building and curating the National Collection thereby ensuring the public's right to free, equitable, and convenient access to the past and present public Government information resources. Additional focus is given to transforming the Library Services & Content Management (LSCM) business unit into a primarily digital content and services organization.



Goals

- Federal depository libraries will meet the Government information needs of the communities they serve.
- More online official Government content will be accessible to depository libraries and the public at large.
- GPO's Catalog of U.S. Government Publications will be a comprehensive index to the corpus of Federal Government information.
- Tangible collections in Federal depository libraries will be maintained for access.
- The National Collection of U.S. Government Information will be preserved and accessible to future generations.
