**Elissa Lawrence** -> All Participants: That doesn't work for reference/library use only materials

**Andrea Stelljes** -> All Participants: At Hennepin County--Minneapolis Central our government publications do not circulate so that presents a challenge for our users. It's important for us to be able to increase access through online/digital publications.

**Elisabeth Garner** -> All Participants: @Andrea, that's a good point

**Virginia Thomas** -> All Participants: In terms of FDLP content, can you provide a general overview of resources that are offered to FDLP libraries online that are not also available to the public generally via the Internet? This question goes to the issue of why libraries may/may not wish to continue with

depository status -- or seek FDLP status.

**Kathryn Bayer** -> All Participants: FDLs can get free catalog records through the Cataloging Record Distribution Program: <https://www.fdlp.gov/cataloging-and-classification/cataloging-record-distribution-program> MARCIVE is the contractor. We have openings!

**Virginia Thomas** -> All Participants: Excellent points, all. Do you see the FDLP reaching out to non-depositories with training opportunities at some point in order to facilitate effective use of government information?

**Jennifer Morgan** -> All Participants: @Jenny, re: a government shutdown, there are essential government services that will still continue. It is my understanding that during a shutdown, GPO remains minimally staffed to produce essential publications and govinfo will remain online and updated. **Elisabeth Garner** -> All Participants: Regarding the "continuing ed" option. I think the FDLP does a great job of announcing webinars and training/modules/webinars for those of us who might be coordinators. They send out separate emails as well to highlight those trainings. We can always stay "in the loop" with FDLP/GPO

**Amy Laub-Carroll** -> All Participants: I send those webinar announcements to fellow faculty as well as the Kentucky Library Association GODORT listserv

**Jennifer Morgan** -> All Participants: Jenny asked earlier, "I have asked several times (yesterday, Spring DLC, other times) - what happens when federal agency sites go down during shut downs? Even if we got equitable online access to entire country (I can dream) - it doesn't matter if government shuts down. This has happened."

**Kate Pitcher** -> All Participants: There are essential employees in GPO to maintain the GPO tools during a government shutdown (i.e. FDLP.gov, CGP, etc.)

**Elissa Lawrence** -> All Participants: @Jennry re: going all-digital for libraries going forward... in Ohio, we have a number of academic and large public libraries who want to transition to online-only AND discard their entire tangible collection. Some of these collections seem to be the first looked at when needing to give up space to the larger institution. I try to remind them that it's not an "all or nothing" situation, but they're intent on giving up most--if not all--print pubs. It's disheartening.

**Andrea Stelljes** -> All Participants: At Hennepin County Library--Minneapolis Central, an FDL since 1893, we plan to keep our historic print collection, but will adjust our selection profile for fewer print publications going forward

**Elisabeth Garner** -> All Participants: It also helps when the Dean of your library, (as is the case here at Randall Library-UNC Wilmington) is a huge proponent of the FDLP

**Rich Gause** -> All Participants: Extremely clear messaging is very important. The only takeaway many directors got from the ASERL Centers of Excellence project was that other libraries were taking on responsibility and they could throw away all their local documents collections and repurpose those spaces.

**Jennifer Morgan** -> All Participants: It's important to offer your discards on FDLP eXchange, even if you aren't required to.
