

Digital Imaging Workflow






Digital Specifications

- Follow the Federal Agencies Digital Guidelines Initiative's <u>"Technical Guidelines for Digiting Cultural Heritage Materials"</u> three-star level.
 - 400 ppi (original document size) with 24-bit RGB color.
 - Master file format: JPEG 2000 with up to a 20:1 lossless compression ratio.
 - Searchable and optimized PDFs compliant to the PDF/A2-b format specification standard.
 - OCR text saved as .txt file format for each publication.
 - Pages should have no visible skew (no more than between 0-1 degrees)
 - Pages cropped so the page edge is showing with a border of no less than
 1/16 inch and no larger than ¼ inch.



United States Reports

- Cases of the Supreme Court of the United States
- Compiled and published by the Reporter of Decisions
- Contains more than just cases decided by the Court
- Scope of the GovInfo collection: volumes 2-501
- Volumes acquired from discarding Federal depository libraries
