If a PURL points to an agency website and the resource is removed by the agency GPO redirects to our harvest. Not every online resource can be successfully harvested, but we make every effort to restore access. (Note: CGP records created after 2018 consistently include the URL at time of harvest, which may be helpful to see if other web archives have a copy).
